Our mission is to equip men and women with the tools to make the minor adjustments necessary to obtain and maintain productive, healthy lifestyles as they successfully reintegrate into society following incarceration or rehabilitation.

ABOUT US

Minor Adjustments Group, Inc. was founded in 2013 by Michael L. Williams Jr. and his wife, whose shared vision was born out of lived experience and a deep understanding of the challenges individuals face during reentry. After more than 22 years spent in prisons, jails, and rehabilitation programs, Michael personally experienced the hardships of reintegrating into society and the determination required to rebuild a productive life.

Motivated by that journey, Michael and his wife committed themselves to serving individuals facing the same struggles he once endured. Now a Certified Alcohol and Drug Counselor (CADC), National Certified Peer Recovery Support Specialist (NCPRSS), and ten-time published author, Michael combines professional training with real-world experience to deliver impactful programs, resources, and support that promote lasting transformation.

Funding will support the delivery of our 8-week courses and help launch the House of Adjustments Discipleship Home. We recognize that returning to former environments associated with substance use or criminal activity can be stressful and triggering. Our goal is to provide structure and support that promote a smooth, stable transition back into the community.

OUR SOLUTIONS

Our primary program offering is an 8-week course, consisting of one session per week. Throughout the program, facilitators guide participants through The Minor Adjustments Workbook, using interactive and evidence-informed approaches designed to empower individuals to take ownership of their lives.

Program success is measured by reduced rates of recidivism within the communities we serve.
