Who We Are

This Privacy Policy applies to the official online platforms, application portals, and services of **House of Adjustments Discipleship Home**, an outreach program owned and operated by **Minor Adjustments Group, Inc.**, a registered 501(c)(3) non-profit organization with a mailing address at **P.O. Our platforms provide information regarding our discipleship and recovery residences, support services, admissions applications, and community outreach.

About Your Privacy

House of Adjustments and Minor Adjustments Group, Inc. respect your privacy and are committed to safeguarding your personal information. This Privacy Policy outlines how we collect, handle, and protect your information across our website, electronic application forms, and communications.

What Information We Collect and Why

We collect personal information when you interact with our website, request information, or submit forms, including our residency inquiries and intake applications.

1. Information You Provide to Us

- Full legal name, date of birth, and contact information (phone, email, mailing address).
- Emergency contact details.
- Information relevant to residency readiness, referral sources, or transitional support needs.

2. Automatic Data Collection

- IP address, browser type, and device specifications.
- Referral source and activity across our web pages.
- Standard session cookies (which you can control or disable through your browser settings).

3. Referral & Third-Party Information

We may receive prospective resident details from third-party community partners, including treatment centers, correctional institutions, case managers, or healthcare coordinators. This

information is held under the same confidential and secure standards as direct submissions.

How We Use and Protect Your Data

- No Sale or Commercial Renting: We do not sell, trade, or rent personal data or applicant records to third parties.
- Limited Operational Sharing: Data is only shared with trusted service providers strictly necessary to operate our organization.
- Confidentiality Standards: All resident intake data, recovery inquiries, and application files are stored securely with strict internal access controls.
- SMS Privacy: Mobile information, phone numbers, and SMS consent will not be sold, rented, or shared with third parties or affiliates for marketing or promotional purposes.

Your Data Rights & Retention

We retain application files, intake logs, and general communications only as long as necessary to fulfill operational, transitional housing, or legal recordkeeping requirements. You may request access, correction, or deletion of eligible records subject to applicable legal requirements.

SMS/Text Messaging Policy & Terms

- Message Content: Transactional notices, application updates, appointment confirmations, or community updates.
- Frequency & Rates: Message frequency varies; standard message and data rates may apply.
- Opt-Out: Reply STOP at any time to discontinue messages.
